Town of Edson Doctor Attraction and Retention

(Town of Edson) The Town of Edson understands the challenges being faced by rural Alberta when it comes to attracting and keeping medical professionals in the community.

While the Town is pleased to hear that two new doctors are planning to relocate to Edson, efforts continue to be made to attract and retain medical professionals.

One of Edson's main attraction features for this field is the new hospital. The Edson Healthcare Centre opened its doors in 2016 and features top of the line health services, including acute care, continuing care, inter-professional primary health care, and community health programs.

However, even with a new facility, it can be difficult to attract physicians to practice in rural Alberta as opposed to larger cities.

"Our local physicians have been working very hard ensuring the ER has coverage while providing services at the Medical Clinic. Our goal is to get back to a full complement of doctors so they can start accepting patients again and lessen the burden on existing physicians. We thank all our medical professionals for their commitment to Edson and look

forward to welcoming new physicians to the community. Council is committed to continuing to collaborate with our partners to ensure we can attract and retain medical professionals to Edson," stated Edson Mayor Kevin Zahara

Attracting and maintaining a solid number of physicians in our community touches nearly all aspects of Council's Strategic Plan, most specifically Creating a Connected Community that is Safe and Inclusive.

With that in mind, the Town of Edson has been working to create a positive working environment for medical professionals and advancing creative solutions to the issues they face.

In 2011, the Town of Edson purchased the Edson Medical Centre to help maintain a stable work environment for doctors. Recently, the Town has worked with the local doctor's group on updates to the Medical Centre lease to help reduce overhead and realign costs with current market values.

The Town of Edson and Yellowhead County partnered on the purchase of a home in 2012 to help provide transitional housing for medical professionals as they relocate to our community.

Currently, Town staff are working closely with the Edson and District Community Care Foundation, Hospital Administration, the Rural Health Professions Action Plan group, and other organizations to build relationships and come up with more strategic plans to make Edson a workplace of choice for doctors, nurse practitioners, and other professionals.

Town staff are also working directly with medical students in the

The Edson Food Bank has seen a significant increase in the amount of food they are going through. More families are depending on their help.



Business Licence Renewals



With the beginning of every year, we would like to kindly remind our business owners to renew their business licence before the February 15th deadline for

The following changes were enacted last year with the updating of the Business Licence Bylaw.

- 1. Following a review and comparison of fees from similar sized municipalities, the fee structure has been adjusted and 'early bird discount' has been repealed;
- 2. Although Business Licences technically expire at the end of the year. Your business will remain compliant and is allowed to operate within the Town up until the February 15th deadline. Per our newly enacted Business Licence Bylaw No. 2280, failure to renew by February 15th, would deem the Business Licence invalid and the Business not being permitted to operate within Town limits until such a time when the Business Licence is renewed; and
- 3. Moving forward, to reduce paper waste, the Town of Edson will no longer be issuing paper Business Licence Certificates annually. We would ask business owners reaching their 5-year mark to place their new Business Licence stickers over the older stickers on the certificate.

Trudeau punishing Canadians for surviving cold winter

Families brace for skyrocketing heat bills as Trudeau carbon taxes bite.

Millions of Canadians are keeping an anxious eve on their thermostats, praying the power stays on and bracing for carbon-taxed heat bills to arrive.

A frigid winter cold snap delivered daytime temperatures in the minus 30s with overnight wind chills of over minus 50 in parts of Canada. Natural gas furnaces are running around the clock, keeping families from freezing and water pipes from bursting.

The situation got scary Saturday when an Alberta-wide alarm blared across smartphones, TVs and radios. The province warned the power grid was maxing out and rolling blackouts were about to hit.

Alberta Premier Danielle Smith took to social media imploring Albertans to turn off their lights, stop using appliances and hunker down to save the power grid from blacking out. Saskatchewan Premier Scott Moe tagged in, announcing his province was sending 153 megawatts to Alberta.

When it's minus 40, running the furnace isn't a luxury; it's a necessity. And yet, Prime Minister Justin Trudeau is punishing Canadians with a carbon tax for the sin of staying warm and staying alive in winter.

The federal carbon tax is currently set at \$65 per tonne, costing 12 cents per cubic meter of natural gas and 10 cents per litre of propane. An average Canadian home uses about 2,385 cubic metres of natural gas per year, so the carbon tax will cost them about \$300 extra to heat their home.

Even after the rebates, average families will be out hundreds of dollars this year because of the higher heating bills, gas prices, inflation and the economic damage that comes with the carbon tax, according to the Parliamentary Budget Officer.

But the Trudeau government isn't done. On April 1, the carbon tax is going up to \$80 per tonne. That will cost 15 cents per cubic metre of natural gas.

In fact, Trudeau plans to crank up his carbon tax every year. Over the next three years, Trudeau's carbon tax will cost the average family \$1,100 on natural gas alone.

Canada is a cold place. Keeping the heat on isn't a luxury; it's a necessity. And Trudeau's carbon tax punishes families who need to stay warm during the winter months. Even worse, Trudeau knows the carbon tax makes it more expensive for families to keep warm.

"We are putting more money back in your pocket and making it easier for you to find affordable, long-term solutions to heat your home," Trudeau said when he removed the carbon tax from home heating oil for three years.

This was an admission of an obvious reality: the carbon tax makes life more expensive. Otherwise, why would Trudeau take the carbon tax off a form of heating energy?

Trudeau's carbon tax-carve out was a political ploy to keep his Atlantic MPs from revolting while support for the Liberals plummeted in their typical stronghold.

While many Atlantic Canadians use heating oil, 97 percent of Canadian families use other forms of energy, like natural gas or propane, and won't get any relief from the feds this winter.

Even in Atlantic Canada, 77 percent of people want carbon tax relief for all Canadians this winter, according to a Leger poll commission by the Canadian Taxpayers Federation. Provincial politicians of all stripes have demanded the feds take the carbon tax off everyone's heating bill.

That's because staying warm isn't a partisan issue. All Canadians need to heat their home. And we shouldn't be punished with a tax just to survive the winter.

Trudeau should completely scrap his carbon tax. But at the very least, he should extend the same relief he provided to Atlantic Canadians and take the carbon tax off everyone's home heating bill.







Preventing Cumulative Stress

(AHS) Imagine running a marathon. Now imagine running another marathon immediately after with zero recovery time. Then another. Then another.

Cumulative stress is a bit like running consecutive marathons, except in this case there is little to show for it. Instead, chronically stressful situations with no reprieve have a harmful impact on your body and mind.

Cumulative stress has been defined as a common experience for people who work in chronically stressful situations. It can be the result of an accumulation of a heavy workload, poor communications, multiple frustrations, coping with situations in which you feel powerless, or the inability to rest or relax. It can be experienced in both work and personal lives and exacerbates stress levels in both areas of your life.

Moderate and contained stress can be a source of motivation, inspiration, and energy. However, prolonged and negative stress stimulates the level of stress hormones that can impact your emotions, thoughts, and physiological responses.

Possible Cumulative Stress Reactions: If you are experiencing cumulative stress, here are possible reactions you may notice:

- Difficulty concentrating
- Feelings of hopelessness, powerlessness, and cynicism
- Sleep disturbances and chronic exhaustion
- Irritability and angry eruptions
- Chronic criticism and blaming of others
- Withdrawal from others
- Depression and anxiety
- Increased substance use/abuse What can you do?

There are many things you can do to

improve your stress levels. Keep in mind that resilience should be a key part of a well thought out self-care plan that supports your ongoing personal and professional wellness needs.

Here are some suggestions or ways of reframing your thoughts:

- If possible, can you spot the silver lining? Researchers suggest that perception plays a key role in how we manage stress.

- Maintain good sleeping habits. Avoid using electronics (i.e.: cellphone, tablet, laptop, etc.) at least one hour prior to bed. Having healthy sleep patterns will support your recovery.

County project to showcase community resiliency during fire and flood disasters

During the Yellowhead County Council meeting on January 23, CAO Luc Mercier presented council with an overview of the proposed project 'Our Uncompromising Communities'.

Yellowhead County Council previously directed Administration to prepare options for how the County could document the fire and flood disasters of 2023, highlighting the resiliency and strength of our communities.

"During the budget process, the idea that Council put forward and put \$100,000 as a place marker for, was to look at options to capture the 2023 disasters, the fires and the flooding, so we could keep that as part of our history and document it," said Mercier.

During the spring emergencies of 2023, residents, first responders, and staff demonstrated remarkable resilience in the face of adversity. Despite these challenges, our communities came together to support one another and overcome obstacles. Documenting this experience will serve as a testament to the strength and determination of our residents and will allow our communities to come together to share their collective experiences, Mercier stated.

The project dubbed 'Our Uncompromising Communities' is to document the stories of Yellowhead County related to the spring 2023 emergencies. These stories may be showcased through seven proposed distinct projects with a projected total of \$100,000:

- Highlighting our Resilience (no cost)
- Making our Mark (\$14,000)
- Celebrating our Hamlets (\$33,000)
- Sharing our Story (\$15,000)

- Displaying our Experience (\$4,000)
- Recording our History (\$29,000)
- Showcasing our Growth (\$5,000)

The proposed plan for the project includes a book, community displays, murals, artwork displays, and other associated material. Upon completion, each hamlet would host an opening day/evening for the exhibit, mural, and book. The event would feature food for the community, speakers, interview clips, and giveaways.

Councillor Dawn Mitchell said, "I think this captures the will of Council, and as usual, Administration expanded on it and just made it into something so much better. We have an amazing number of brilliant artists in Yellowhead County... this is a living history, I like it."

Councillor Penny Lowe said, "I guess I looked at this a little bit differently. It was a very large piece of history for Yellowhead County. I really am against doing a mural or artwork or something as you enter in one of our hamlets, because to me that's labelling that hamlet. As you're driving in you want to have something positive and not of a negative nature. Not only that, but it's very difficult for a lot of people to deal with. I think that constant reminder would be there every time you drive into town and I think it would not serve the purpose of what Council is trying to do. Yes, it happened, but it was a negative impact on that community."

Councillor David Russell said, "I can certainly empathize with counselor Lowe's position. I totally understand that and you don't want to repeat that over and over again. So it can be looked at and studied as to how much visual arts needs to be attached to this."

Mitchell responded, "I hadn't looked at it from the

negative. I truly had looked at it from the positive, in my mind's eye. Maybe people holding hands? I think we came out on the other side bigger, better, stronger, right?"

Councillor Anthony Giezen said, "from my perspective, I support the whole program. I think it has to be done tastefully and in the right way. But I think if we truly want to capture the event, we have to have it open and as broad as we can."

Councillor David Russell moved that Council for Yellowhead County direct Administration to proceed with Highlighting Our Resilience, Sharing Our Story, and Recording Our History projects for documenting the spring 2023 wildfire and flood emergencies as presented in "Our Uncompromising Communities"; and further, that Administration forward the remaining projects to a Governance and Priorities Committee Meeting for further discussion. This was carried unanimously.

Letter of Support: The Wildwood Agricultural Society requested a Letter of Support from the Yellowhead County for their 85th Annual Wildwood Fair 2024 Community Initiatives Program grant application for \$8,500.00. The grant money is to allow the Society to host extra activities such as bringing in a mechanical bull and climbing wall and to include fireworks at this year's fair. "The fair has always been a well-attended event. It is a source of pride for the community and an integral part of Wildwood's summer schedule," Derek Starnes, Parks and Recreation Supervisor for the County. Council voted to approved the letter expressing support for Ag Society's 85th Annual Fair Community Initiatives Program Grant application.

All first place winners will be going on to the District Public Speaking event on February 10.







snowmobile and grooming plate. A SkiDoo Tundra 600 will tow a grooming plate that will even out the trail tread and make Fat Biking much more fun and smooth. This has been in the works for a while now and all the pieces have come together to deliver year round cycling to Willmore Park.

As warmer weather approaches, the trail surface will tighten up and become much more firm with regular use and grooming. One way to help the ECA out on this is to be mindful of how deep your tires are sinking into the surface and adjust tire pressure to minimize damage to the trail. Another great way to help out is to wear snowshoes when walking the trails to reduce the impact boots or shoes have on the trail surface.

If you are sinking more than 1"(2.5cm) please adjust your tire pressure, wear snowshoes or wait for the trail surface to harden.

As the weather changes and we

get more snow, the grooming machine will be making regular passes to maintain the trails.


"We are continuously reviewing and updating our donor screening criteria. You may be eligible now, even if you weren't before."







Looking back on the 2023 cattle market

"The past year saw average monthly prices for fed steers in Alberta peak in June at \$246.61 per hundredweight," says Ann Boyda, provincial livestock market analyst with the Alberta government. "Feeder prices were also historically high, peaking in September at \$397.90 per hundredweight and \$328.41 per hundredweight for 550-pound and 850-pound steers, respectively. Cow prices were also strong, peaking at \$153.64 per hundredweight in July for cows in good condition. Strong prices seem poised to continue into 2024, in part, due to smaller cattle inventories.'

Statistics Canada's supply and disposition data for total cattle in Alberta reflects the contraction experienced in the first half of 2023. The January to June 2023 cattle supply of 6.757 million head was estimated to be 2.6% lower than that of the same period in 2022. Supply estimates take into account the beginning inventory, calves born, interprovincial imports and international imports. The inventory estimates as of January 2024 are currently being compiled and expected to be released in early February.

What has attributed to this decline? Many sources point to drought conditions and concerns of feed availability. Higher calf and feeder prices also encouraged greater placement of cattle into feedlots, removing future inventory.

"2024 may be starting with smaller cattle inventories but high prices may still provide incentive to rebuild," points out Boyda. "The cold weather may cause feedlots to hold back cattle which could increase bid prices in the near term. Current signals suggest that the rebuild may still be a ways off."

Heifer placements on feed are still commanding a high share of the total cattle placed on feed. June 2023 witnessed a higher proportion of heifers enter feedlots (53.5%), exceeding 2022 proportionate share and that of the 5-year average for June of

40%. Signs of producers retaining more heifers for replacement did not emerge for the remainder of 2023.

Although total cattle slaughter volume of over 2.5 million head in Western Canada decreased by approximately 3.6% in 2023 versus 2022, cow slaughter volume of 379,565 head increased by 7.9% over the same period. Continued high levels of cow slaughter pressure the beef supply going forward.

"In 2023, dry conditions, high costs and interest rates, limited labour and economic uncertainty held back any plans for growth. Restocking droughtreduced cow herds takes time so any expansion will be slow. How long this will take rests with predictions of weather, beef demand and profitability. So far, beef demand has proven robust even with higher prices relative to other proteins.

"Cow-calf producers have recovered positive margins last year and are hoping to sustain favourable margins into the near future. Even feedlot operators enjoyed some months of positive margins in 2023, although higher prices paid for feeders last year may result in tighter returns in the first half of 2024. Overall, 2024 has some prospect of being a good year, especially for the cow-calf sector, but weather remains the greatest risk factor," says Boyda. -AgriNews
