## **County explores options for new Community Hall in Evansburg**

During Yellowhead County's August 16 Governance Community Services, stated that following Council and Priorities Meeting, Administration presented direction a tour of Evansburg was completed on Council with four options for consideration for the construction of a new community hall in Evansburg.

The Evansburg Legion currently serves as the Pembina Rec-Plex/Evansburg Arena; An addition community hall for Evansburg and area residents, to the Tipple Park Museum; A new stand-alone hall however, this facility is listed for sale and should it close, on the Evansview School site, pending the school's the hamlet would be left without a suitable event space to closure; or a new stand-alone hall in the hamlet.



serve this function.

Crystal McNernie, Interim General Manager of Community Services, stated that following Council direction a tour of Evansburg was completed on September 22 to familiarize Council with the four options being considered: An addition to the Pembina Rec-Plex/Evansburg Arena; An addition to the Tipple Park Museum; A new stand-alone hall on the Evansview School site, pending the school's closure; or a new stand-alone hall in the hamlet.

Estimated costs for a new build is (+-) \$400 per square foot. The current Legion community hall is approximately 7,500 square feet and contains event space, a commercial kitchen, and a wet bar. A new community hall replicating these program areas should be expected to total (+-) \$3M, stated McNernie.

Administration recommended including this project in the 2023 budget cycle and undertaking the new build on the following timeline:

- Investigate all options for the addition of a community hall to the Evansburg Arena (2023).

- Develop the site-related concept(s), conduct geotechnical and other studies, and design in detail (2023).

- Tender and construct (2024).

Councillor Brigitte Lemieux stated, "After seeing the four sites I support the placement of a new community hall next to the arena as I think there is great potential for synergies."

Councillor Dawn Mitchell stated, "I echo what Councillor Lemieux said... it was a good tour."

Councillor Shawn Berry said, "After reviewing the options, I do think the option being presented by Administration is the right way to go."

Councillor Anthony Giezen, said, "I agree with the general statement. Only one concern I have is the addition might be a stand-alone and it doesn't necessarily have to be something integrated into the same structure."

Mayor Wade Williams added, "I do agree that the council tour really helped open everyone's eyes to what the options are. And I do agree the recommendation by Administration is probably the

best option."

Councillor Patrick Soroka made the motion that Council for Yellowhead County approves proceeding with option considerations for the addition of a community hall to the Evansburg Arena; and that Council for Yellowhead County directs Administration to allocate funds in the 2023 budget to complete an overview and conceptual design report for a community hall addition to the Evansburg Arena.

Council voted all in favour of the motion.





Preamble comment by Dana McArthur:

Premier Danielle Smith's comments at her inaugural press conference offer a glance into the world of hard-right populism.

Referring to the small minority of unvaccinated Albertans during the Covid lockdowns: "They're the most discriminated against group that I've ever witnessed in my lifetime." She later attempted to clarify that befuddling statement, but did not retract and apologise for it.

For many, vaccine mandates were a necessary, live-saving response to the crisis. And for others they were a heavy-handed approach, to say the least.

However, her comparison disregards the injustice and discrimination faced by many other groups throughout her 51 years. It disregards the ongoing struggles for Truth and Reconciliation of Indigenous Peoples. It disregards the generational struggle against discrimination of all minority and marginalized groups. It disregards the ongoing discrimination faced by the LGBTQIA2S+ community, despite their best efforts. And it disregards the ever-present undercurrent of discrimination towards people with disabilities or those struggling with mental illness -just to name a few.

Not only did Smith offend every single minority and marginalized person in the province, Alberta's newest premier turned our province into a national and worldwide embarrassment.

Deeply troubling populist statements like this are often born in an 'echo chamber' where one surrounds themselves with only those who agree. Let's hope that this is not the case for a premier who needs to represent ALL Albertans.

Below is a release from the **Diversecities Community Services** Association that speaks with generational experience on this issue.

#### **Marginalized groups** disagree with Premier **Smith's declaration** regarding 'most discriminated against'

integration and a sense of belonging with Calgary and region.

Diversecities

support Alberta's vaccination strategies and believe it is one of the biggest reasons for the quick turnaround of Alberta's economy.

We disagree with the statement made by the Alberta Premier, Danielle Smith, this past October 11, 2022, claiming that people who have chosen not to get a Covid-19 vaccine have been the "most discriminated against group that she has ever witnessed in her lifetime."

Alex Montiel, Chief Executive Officer of Diversecities, says: "We understand that being unable to retain or find a job, having restricted mobility across the country or not being allowed to enter a public gathering based on a medical choice can be considered discrimination. However, this is incomparable to the uncountable cases of people who have been verbally and physically assaulted in the street while walking with their children, demanding them to return to where they belong because they are of Asian descent."

There have also been tragic cases of people who have been assaulted and killed for having a different skin colour or cultural heritage or people who have been killed or prosecuted around the world for having a different political opinion, wanting to express their opinion in an open and free manner or are seeking equals rights for themselves and communities.

Montiel says, "Diversecities, as well as many other community organizations in Calgary and Alberta, have invested the last years developing community education projects to visualize, decrease and address racism and hate crimes against visible minorities, including the Asian communities.'

Diversecities programs have helped people who are victims of physical, verbal and emotional assaults and abuses due to their heritage, physical appearance, religious beliefs or something as trivial as the way they speak. Some of those projects are also funded by the Government of Alberta through the Alberta Culture and Status of Women's Community Initiatives Program. On May 25th of the current year, the Government of Alberta appointed a series of Community Liaison Officers to work in coordination with the Government of Alberta Hate Crimes Coordination Unit and Alberta Anti-Racism Advisory Council to initiate community dialogues about the increase in hate crimes in the province with the goal of presenting a work plan to address this problem. Montiel said, "For this reason, we

Finally, Montiel said, "We are hopeful that Premier Smith will reflect on her recent declarations and how they can be perceived as unsensible, harmful and incorrect to the diverse communities that integrate Alberta's social mosaic."

# **Premier Smith walks back** remarks on Russia invasion of Ukraine

"I categorically condemn the Russian invasion of Ukraine and the indescribable suffering Russia has and still is inflicting upon the Ukrainian people," stated Premier Danielle Smith, in a release apologizing for previous remarks on the Russian invasion of Ukraine.

"Prior to re-entering politics earlier this year, I made some illinformed comments on Russia's invasion of Ukraine. My knowledge and opinion of this matter have drastically evolved since that time, and I apologize for those previous comments," Smith stated in the release.

In a livestream on April 29 this year on Locals.com, Smith was asked her thoughts on the peace plan for Ukraine and Russia. She answered with a hypothetical scenario where Canada has nuclear weapons and is aligned with Russia, and how that would upset the U.S. "So, why would we be surprised if Russia is upset because Ukraine has nuclear

weapons and is aligned with the United States?" she said. "I think the only answer for Ukraine is neutrality," Smith stated.

On Feb. 24 of this year, Smith also posted that she wondered if areas of Ukraine should be allowed to break away and govern themselves independently. "It seems to me the great powers of the world did a terrible job defining the new borders of countries after WWII. So much of the conflict we have had since is due to different people being crammed under one national government that don't like each other," the post said. She also suggested Ukraine give up its nuclear weapons.

In the apology release, Smith added, "I have directed my office to actively reach out to Alberta's Ukrainian community leaders in order to ascertain immediate steps we can take to assist Ukrainian refugees to settle and integrate into communities across Alberta as quickly as possible." Smith concluded, "I stand with Ukraine and the Ukrainian people."





## Caution advised with cooking and warming fires this season

The wildfire season in Alberta officially ends on October 31, but that does not mean that the wildfire danger will dissolve with the change of seasons. Although we are experiencing cool fall weather in the evenings, hot daytime temperatures and lack of significant precipitation are keeping the fire danger elevated.

The 5.9 ha wildfire that was detected 45 km east-southeast of Edson over the long weekend of October is a true testament to how dry and favourable the conditions are for a wildfire. Grass and small ground debris like branches and needles are considerably dry and will continue to be if rain or snow doesn't come soon. That means that any spark, friction or hot exhaust could start a wildfire even in colder temperatures. We urge those that work or recreate outdoors to use care and be prepared by carrying sufficient firefighting equipment like water or a shovel, depending on your activity.

This is also the time of year when firefighters find abandoned cooking and warming fires that we believe are left unintentionally by recreationalists and hunters. It's very important to know that all fires must be fully extinguished no matter what time of year it is. A fire built on top of snow can easily smoulder in the debris underneath for weeks and even months and reignite when the wind picks up, or the conditions allow for a wildfire. Last year, 67 per cent of wildfires were human-caused.

When you're planning your fire, choose your site carefully. Hardpacked mineral soil or gravel is best. Scrape away any flammable material and use extra care around dead grass. Keep your fire small and protected from the wind. Ensure your campfire is completely extinguished before you leave. Spread the burning material to reduce the heat. Soak it with water or snow, stir up the ashes and soak it again. Use your bare hands to feel for heat. If the ashes are cold then the campfire is fully extinguished. We really appreciate everyone who is doing their part to prevent human-caused wildfires.



# Baby grave scare leads local resident to investigate history

Betty Stitzenbuger shared some information recently about some graves that have been buried on the family property for as long as she can remember.

"When I was a young girl my brother and I were playing outside when all of a sudden we thought we saw a real bear. It was years later we found out it was my dad with a bear skin rug over him. It was his way of putting a scare into us so we wouldn't go back to that area," said Stitzenbuger.

"There were two baby's graves and nine adult's graves in that area. My dad thought if he told us not to go, we would go anyway to check them out for ourselves —but having a scare might just keep us away."

What you are about to read is some history on the two baby's graves that Betty received recently. The adult's graves they figure were people who may have been working on the Big Eddie bridge way back in history.


— Lea Henderson Miller and Mary L. Fey were married in 1891 in Rolla, Missouri. In 1902, they sold their farm and moved with their five children to another farm in South Dakota, where three more children were born. They spent seven years in South Dakota, but it was hard to make a living for their large family when the crops failed and they had to depend on what they could make from selling cream, for all their needs.

The children were growing up (the oldest was seventeen), and they would soon need employment for more than just one man. They decided, after many hours of planning and study, that they would move to Canada.

They made the trek across half of South Dakota and then through North Dakota to the Canadian border, with all their household necessities loaded in a covered wagon. The oldest boy, Lloyd, drove the team on the wagon, and the next three oldest children rode with him. Lea drove a team on a two seated buggy, and Mary and the younger children rode with him. They all enjoyed the camping along the way.

The Millers crossed the border at Portal. It was too cold for camping any longer so they came the rest of the way to Edmonton by rail, arriving there in November, 1909. The children went to school in Edmonton for two years while their father worked at various jobs with his horses. 1911 saw three Miller men working for Canadian National Railway in Edson, Alberta.

The family moved to Edson and lived in tents until November. In October, twin girls were

The Miller family left their stopping place on March 1, 1912, heading for Grande Prairie on the famous Edson Trail. One sleigh was loaded with machinery, and on the other sleigh they had built a tight floor and erected a tent over it for their living quarters. The caboose held the cook stove, trunks, food supplies, furniture, clothing, and bedrolls for ten people. The family arrived in Grande Prairie within the month of March and set up a more comfortable camp for the family. while the men began looking for suitable land. They stayed there for almost a month. Lea couldn't find land around Grande Prairie, but there were reports of land being surveyed for homesteading in the Pouce Coupe Prairie area, about a hundred miles northwest of Grande Prairie. Lloyd and Lea made the trip there and were pleased to find an area where there was lots of grass for the horses and acres of land that could be easily broken to grow grain. They returned to Grande Prairie and filed on two quarters along Rock Creek. During the month they spent looking for land, they found several lakes between Grande Prairie and Pouce Coupe that were full of muskrats. The boys began trapping them and soon had many pelts to sell. It was a warm day when the Millers began the last leg of their journey.

They now loaded what they could on two wagons and stored the rest of their belongings. The trail wasn't too bad as far as Beaverlodge, but from there on it was very rough. The creeks and the sloughs were all full of water, and it was very muddy, making for slow going. Some days they only went ten miles, and all but the youngest children walked behind the wagons, wading through sloughs and exploring along the way. There were no bridges across the creeks so trees had to be cut and bridges built, but after ten days of travel they finally reached the Pouce Coupe Prairie. They stopped at Trembley's, the only family on the prairie at that time. Mrs. Trembley and Mary Miller became good friends and visited when they could. The Millers were now just fifteen miles from their homesteads. On May 15, 1912, they set up camp on the N. W. quarter of section 33, Township 79, Range 14, West of the 5th Meridian in British Columbia, and began building their new home. The first log cabin was used only one winter, and in 1913 the Millers built a second log home and a barn. When Lea Miller applied for a Post Office, the first log cabin was made into a postal facility to serve the new district. A name had to be submitted and the name chosen was "Rolla" after 

born, but only one of them survived. In 1911, the Edson Trail was cut through from Edson to Grande Prairie, and there was lots of talk about the good land in the Peace River Country. Good land was what the Millers were looking for, so they made their plans for the trip to Grande Prairie. They thought it best to travel early in the spring when the weather would be warmer but the lakes, rivers and muskegs would still be frozen.

Realizing that there was a need for stopping places on the Edson Trail, the Millers set one up at the foot of Breakneck Hill, about forty miles out of Edson, to accommodate travelers going north. They operated their Stopping Place for the winter of 1911-1912, and during that time their three month old baby became ill and died. She was taken back to Edson and buried beside her twin sister.


What happened? The Liberals, NDP and Bloc all voted against our motion.

# **Edson's 2023 Draft Operating Budget introduced**

(Town of Edson) Edson Town Council was introduced to the draft 2023 Operating Budget on October 15.

During the budget consultation earlier in the year, residents identified a desire for a service level increase for roads while maintaining service levels in most other departments. The \$30.5 million draft budget responds to these priorities by increasing the budget for transportation through increased infrastructure funding and snow removal. The budget also includes funds for casual staff to assist with outdoor rinks, a sidewalk maintenance program, and a proposed backflow prevention program.

The draft budget also includes the completion of the final phase of the Covid Recovery Strategy (\$295,000), which was implemented to reduce taxation impacts through the pandemic, including a tax reduction of 5% in 2020. The Town of Edson faces numerous challenges with this budget due to increased inflationary pressures, rising gas and electricity prices, and a substantial mandatory increase in the policing contract. To lessen the taxation impact, additional funds from the Revenue Sharing Agreement with Yellowhead County have been allocated towards the operating budget. Efforts have also been made to reduce spending and increase revenues where possible.

The base budget accounts for 4.52% of the proposed increase, which is comprised of mandatory items such as policing, inflationary costs, compensation, and other obligations including 2.46% for COVID recovery. The additional 3.19% is made up of improved service level changes which were reviewed during the introductory budget meeting with Council.

Council requested further information to

provide costing for the hiring of additional summer students to support the road program, dust control on the Willmore Park access road, and the reinstatement of the skating oval at Water Tower Park on an annual basis. The operational effects and costs for these items will be brought back to Council for further consideration.

When all of this is taken into consideration, the draft budget proposes an approximate taxation increase of 7.71%. Each percent represents approximately \$120,000 in revenue.

The draft budget will be adjusted in the coming weeks before being brought back to Council for deliberation.

The Town of Edson is committed to providing a high level of service to meet the growing demands of our community, all while being fiscally responsible and ensuring long-term sustainability.

In keeping with the Lemonade Day model of spend, share and save motto, Kaylee chose to save half of her profits to reinvest in her business and donate to the local Food Bank organization.

Lemonade Day is a free communitywide program that introduces youth to entrepreneurship by teaching them how to start, own and operate their own lemonade stand. After youth have completed the Lemonade Day curriculum at Lemmy University, they are prepared for the realworld experience of owning their own lemonade stand business. They then partner with local businesses in their towns to setup their stands in high traffic areas on Lemonade Day. Lemonade Day Kids keep all their profits, but they are encouraged by the program to spend some, save some, and share some. As a result, many participants will donate a portion of their profits to a charity of their choice to give back to the community that supports them. We at Community Futures West Yellowhead are proud of Kaylee and her accomplishments. Kaylee is a great example of an entrepreneur and proof of the wonderful impacts our Lemonade Day program can have on Alberta youth.



## Get an assessment of your grain's quality

"One of the services of the Canadian Grain Commission (CGC) is the Harvest Sample Program, which gives producers a free grade on samples from that year's crop," says Neil Blue, provincial crops market analyst with Alberta Agriculture, Forestry and Rural Economic Development. "Producers can then use those grades as part of their crop marketing."

The grade information from the CGC provides the producer with a base grade to compare with grades on those same representative samples provided to crop buyers. Grading is based on both visual opinion and instrument analysis, resulting in



some differences in grades assigned. The CGC grade is unofficial, but is from an independent, noncommercial source. It is not used in negotiating a sale grade, but it gives producers confidence in shopping the market with their product.

On request, the Canadian Grain Commission sends producers postage-paid envelopes in which they can place representative samples and return to the Commission. The Harvest Sample Program can be used for cereal grains, pulses, canola, flaxseed, mustard seed and soybeans. The grading report includes the following valuable information that a producer can use in crop marketing:

- unofficial grade
- dockage assessment on canola

 protein content on barley, beans, chickpeas, lentils, oats, peas and wheat

- oil, protein and chlorophyll content for canola - oil and protein content and iodine value for flaxseed

- oil and protein for mustard seed and soybeans

- falling number for wheat and rye

- vomitoxin (deoxynivalenol or DON) levels for wheat, corn and barley

Grade results are available within 20 business days from when the CGC receives a sample. Producers can submit samples of their newly harvested crops each fall.

"Individual reports remain confidential, but in collecting the grade information, the Commission can assemble and publish aggregated data on crop quality, useful to sellers and both domestic and international buyers," says Blue. "Producers may sign up for the Harvest Sample Program on the website of the Canadian Grain Commission." - AgriNews

The word charity though didn't always represent these things. Its root is the Latin word carus, which means "dear." In Old English, "Charity" was used to describe the love we are called to have for our neighbours.

When Paul gives his famous speech about love in 1 Corinthians 13, it is this word that was used in the old King James Bible - "And now abideth faith, hope, charity, these three; but the greatest of these is charity.'
